SNOW DISRUPTS LEGISLATIVE SCHEDULE...AGAIN

Another snowstorm rolled through Kansas on Wednesday night and Thursday prompting both the House and the Senate to send members home and adjourn until next week. The weather delay comes as the Legislature has one week left to hear and work bills before they debate bills on the House and Senate floor the week of March 21.

Additionally, given the condensed schedule, the Senate is already scheduled to debate three bills on Monday, including the following:

TAX BILLS FILL THE LEGISLATIVE CALENDAR IN THE FINAL WEEKS

A number of tax bills have been introduced, and in many cases heard and worked as the Legislature examines how best to deal with a massive surplus of funds. While some bills are designed to cleanup the tax code and legislation enacted last year, many of them create tax credits, and expand or create new property tax circuit breaker programs. Some tax bills of note include the following:

- <u>SB 540</u> Expanding the selective assistance for effective senior relief (SAFESR) income tax credit for certain residential property taxes paid.
- <u>SB 462</u> Providing a homestead property tax refund to certain persons based on the increase in property tax over the base year property tax amount.
- <u>SB 384</u> Providing an income tax credit for certain qualified property taxes levied on homesteads.
- <u>SB 542</u> Establishing a property tax revenue neutral rate complaint process, authorizing the county clerk to limit the amount of ad valorem taxes to be levied in certain circumstances.
- <u>SB 495</u> Establishing the salt parity act to allow pass-through entities to elect to pay state income tax at the entity level.
- <u>SB 543</u> Allowing the carryforward of certain net operating losses for individuals for Kansas income tax purposes.
- <u>HB 2721</u> Providing a sales tax exemption for sales of over-the-counter drugs.
- <u>HB 2724</u> Excluding the required 20 mills for school districts from the notice and public hearing requirements to exceed the revenue neutral rate for property tax purposes.

Bills of note that have been worked and passed out of committee include:

- <u>SB 180</u> Providing a sales tax exemption for certain purchases by disabled veterans.
- <u>SB 311</u> Sales tax exemption for the Johnson County Christmas Bureau.
- <u>SCR 1619</u> Urging the adoption of the conclusions and recommendations of the 2021 Special Committee on Taxation regarding the fiscal future of Kansas.

Further, <u>SCR 1620</u> was passed out of the Senate Tax Committee on Thursday and has been placed on the Senate Calendar. If passed by both Chambers, a question would be placed on the November ballot that would ask voters to modify the constitution to "require a supermajority of two-thirds of all members of the House of Representatives and Senate to pass bills to enact or amend any law creating any new state tax or increasing the rate of existing state income tax, sales tax, compensating use tax, other excise tax, property tax, estate or inheritance tax or a tax in the nature of such taxes."

The proposal, known in some states as a variation of TABOR or the Taxpayer Bill of Rights, was promoted by some pro-business organizations such as the Kansas Chamber of Commerce and Americans for Prosperity who felt making it harder to raise taxes would help control state spending. Opponents included the Kansas Contractors Association and other organizations who noted that keeping up with infrastructure needs, such as roads and bridges, would become more difficult in bad times if the threshold of votes need to pass a tax increase was higher.

SENATE DEMOCRATS AND REPUBLICANS RELEASE LEGISLATIVE REDISTRICTING MAPS

Separate proposals for legislative redistricting boundaries were released late Thursday by both the Senate Republicans and <u>Senate Democrats</u>. The maps are the first legislative redistricting maps to be released so far this Session.

Of note, the <u>Republican map</u> would group incumbent Senators Tom Holland (D-Baldwin City) and Sen. Beverly Gossage (R-Eudora) together, setting up a potential showdown of incumbents. It would also pair Sen. Michael Fagg (R-El Dorado) with current Senate Vice President Rick Wilborn (R-McPherson). It is rumored that Wilborn is expected to retire at the end of his term.

There is no word yet when the maps will be taken up or when the House will release its maps. While there are no Senate races until 2024, all 125 House members will stand for reelection this fall.

HEALTH SECRETARY CONFIRMED BY FULL SENATE

After several initial battles between the Governor's office and the Republican controlled Senate, the chamber voted <u>32-5</u> to confirm <u>Janet Stanek</u> as the next Secretary for the Kansas Department of Health & Environment (KDHE). During her confirmation, Senators noted that Stanek had done a good job of trying to connect personally with lawmakers and that she was committed to looking forward rather than speak for the actions of her predecessor, Dr. Lee Norman, who stepped down in November.

Stanek also said she would not close churches in the event of another health emergency. During the early days of the COVID-19 pandemic, Governor Laura Kelly was one of the first officials in the country to order closure of churches during the Easter holiday in an attempt to slow the spread of the virus. Stanek's statements promising no similar actions would be taken in the future seemingly went far in securing GOP support for the Democratic appointee.

Stanek has over 35 years of healthcare experience. Notably, she served as an executive at <u>Stormont Vail</u>, the primary hospital in Topeka.

LIABILITY BILL PAIRED WITH HOSPITAL WORKER PROTECTION BILL; PASSES HOUSE

A bill that would protect hospitals, long term care, mental health and HCBS providers, as well as businesses from civil lawsuit claims related to COVID-19 passed the House floor by a <u>large margin</u> on Wednesday as many of those protection are set to lapse at the end of March.

Amendments were also added to <u>Sub for Sub for SB 286</u> that <u>broadened some protections</u> and added the contents of a <u>bill</u> that would enhance penalties for interfering with the conduct of a hospital and its employees.

The bill now heads to the Senate for either a concur or a request to put the bill into Conference Committee.

MEDICAL MARIJUANA BILL TO BE HEARD NEXT WEEK

The Senate Federal & State Affairs Committee will hear a bill next week designed to allow for the sale and use of medical marijuana. <u>SB 560</u>, was released late Friday and is scheduled to be heard Wednesday, Thursday and Friday of next week.

A comprehensive medical marijuana <u>bill</u> was passed in the waning days of the 2021 Session in the House, but was never taken up by the Senate. If passed, this new bill would allow the Senate the ability to gain a position on the issue as the House's version is still alive because of the biannual Session.
