Statehouse Prepares for the 2021 Session

With the COVID-19 pandemic still looming large, legislative leadership and staff have been busy making preparations for what will likely be one of the strangest Sessions on record. The Legislative Coordinating Council, which met December 30, detailed the precautions that were being taken, including: providing proper social distancing in committee rooms, holding committee meetings virtually, and limiting large groups of lawmakers or outside citizens.

In short, to the extent possible, Legislative leaders are trying to conduct business that allows full participation and work on bills of importance, while working within the safety protocols they have put in place for the 2021 Session.

COVID Response Bill Hearings Held First Week of Session

With a looming January 26, 2021 expiration date, members of the House and Senate Judiciary Committees will look to extend most of the COVID Response bill that was passed in a Special Session held in June. <u>HB2016</u> contains several provisions – ranging from the Governor's Emergency Powers, to liability for businesses and healthcare providers, to how to distribute federal stimulus dollars. While several provisions need to be extended just to deal with the continuing pandemic, lawmakers are also looking to modify, extinguish or permanently put in place others. The Senate plans to look at the bill on Tuesday and Wednesday, and the House will work Wednesday and Thursday.

Health Topics Dominate First Week

In addition to hearings on HB2016, committees such as the House Health & Human Services Committee and the Senate Public Health & Welfare Committee will hear updates on other topics such as the COVID vaccine rollout and testing. Please see our updated agenda, below, for more details on the various hearing dates and times.

Governor's State of the State to be Held Virtually

Governor Laura Kelly's office announced that the annual State of the State address will be held virtually, in light of the COVID pandemic. The address will take place on Tuesday, January 12 at 7 PM. In addition to local Kansas television stations, the speech can be viewed on the <u>Governor's Facebook Page</u>.
