First Week of Session Concludes

The first week of the 2021 Kansas Legislative Session wrapped up on Friday. Unlike previous years, where informational hearings and agency presentations typically dominate, several crucial pieces of legislation were advanced.

Of note, both the House and the Senate Judiciary Committees heard bills this week that would extend last year's <u>HB2016</u>, pertaining to the **Kansas Emergency Management Act** (in response to the ongoing COVID-19 pandemic). The House bill advanced out of committee and will be taken up by the full body next week and the <u>Senate</u> advanced their <u>version</u> of the extension last night.

The <u>Senate</u> passed a <u>property tax transparency bill</u> last night, as well, which proponents hope will provide additional notice and hearing requirements for any taxing subdivision. The bill would also remove the property tax lid, which currently requires local units of government to hold a public vote before increasing property taxes (with some exceptions). The bill will now head to the House Taxation Committee where a hearing was just scheduled for Wednesday, January 20 at 3:30 PM.

From an "on the ground" perspective, the hallways were much quieter than usual given that fewer individuals were permitted to enter the Statehouse. To accommodate members of the public and

legislators who wished to still view and testify in committee hearings, the Legislature upgraded many of the digital systems in the over 150-year-old building. While these systems were riddled with issues all week, IT staff hope to have things better working by the time lawmakers return for business next Tuesday.

Access to Statehouse Limited

House and Senate Leadership received a memorandum from the Governor's office that would limit entrance to the Statehouse to those who have official business under the dome, including legislators and lobbyists. The announcement, released Thursday, note that because of FBI alerts about potentially violent protests at capitol buildings across the country, these extra measures were being taken. Conferees will still be able to testify virtually, and the general public can view proceedings online as well.

Governor's Budget Revealed

On Wednesday, the Governor revealed her 2021 budget. The proposal will now be submitted to both the House and Senate budget committees where they will add, delete or affirm recommendations. Items of note in this year's budget include:

- Reamortization of KPERS over 25 years. This would free up \$158.7 million of SGF in FY22 to provide more certainty given the ongoing pandemic.
- Funding to expand Medicaid, in the event the Legislature chooses to do so.
- Retail Sales & Compensating Use Taxes on Digital Property and make changes to tax code so that Marketplace Facilitators collect sales tax as well. The Governor's office estimates this would bring in \$85.8 million in FY22.
- Investment in the state's IT infrastructure, including:
 - \$37.5 million between FY21 and FY22 from Federal and revenue funds for Unemployment Insurance modernization efforts at the Department of Labor
 - \$3.1 million for Juvenile and Offender Management Information Systems
 - \$2.0 million for Electronic Health Record support and maintenance
 - o \$1.0 million for Comprehensive Child Welfare Information System
 - o \$4.3 million for general state IT rehab and repair
 - \$6.6 million for KPERS IT modernization
- Reduce reliance on transfers from the Kansas Department of Transportation, with a plan to phase out transfers by FY23 and continued funding of the Eisenhower Legacy Plan (comprehensive transportation program passed in 2020).
- A 2.5% pay increase for all state employees.

Abortion Resolution Proponents Renew Efforts in 2021

Lawmakers pushed forward with a proposal that would allow voters to choose whether the Kansas Constitution provides a **constitutional right to abortion**. The "Value Them Both" amendment, as it has been called by pro-life advocates, was stalled last year in the House when several moderate Republicans did not vote in favor of the measure. Committees in both the House and Senate will continue to hear the resolution over the next several days.
