WORKER'S COMPENSATION REFORM BILL SHUTTLED THROUGH COMMITTEE

A negotiated Worker's Compensation Reform bill was heard and worked this past week. <u>SB 430</u> was approved by the <u>Senate Commerce Committee</u> on Wednesday. Major changes included adjusting the caps, (summarized below; current caps in parentheses):

- Death = \$500,000 (\$300,000)
- Permanent Total Disability = \$400,000 (\$155,000)
- Must prove at least 10% PPD to be eligible for PTD benefits.
- Still must prove Claimant is realistically and essentially unemployable
- Permanent Partial Disability = \$225,000 (\$130,000)
- Functional Only = \$100,000 (\$75,000)

The caps will remain fixed until July 1, 2027, at which time a cost of living increase (COLA) will start to raise caps yearly on July 1. This will be based on a 5-year average of the percentage increase in the State average weekly wage.

A date has not yet been set for the bill to be brought up for a debate on the Senate Floor.

INCENTIVE BILL AIMED TO LURE DATA CENTERS SET TO BE WORKED

A bill that was first introduced and heard last year is set to be worked in the <u>House Commerce</u> <u>Committee</u>.

<u>HB 2450</u> would provide a sales tax exemption for the purpose of constructing, reconstructing, enlarging, or remodeling a data center. The sales tax exemption would apply to the sale and installation of certain data center equipment and eligible data center costs purchased by the firm for the data center, electricity used by the data center, and labor services to install, apply, repair, service, alter, or maintain data center equipment.

The sales tax exemption would also be extended to any contractor hired for the constructing, reconstructing, enlarging, or remodeling of a data center.

A qualified data center would commit to an investment of at least \$600 million within the first five calendar years after commencement of construction and maintain at least 20 new jobs within two calendar years after the data center begins operation. The sales tax exemption would be valid for 30 years after commencement of construction for a qualified firm making an investment of at least \$600 million in a qualified data center, 40 years for an investment of at least \$800 million, and indefinitely for an investment of at least \$1 billion.

The bill comes at a time when data centers have been popping up across the region. The Kansas City metro area alone has had two data centers recently locate to the area.

The bill is set to be discussed and a vote will take place on Monday.

TAX WITHHOLDING BILL FOR THOSE WORKING IN MULTIPLE STATES TO BE HEARD

Remote workers may find some reprieve under a new House proposal.

<u>HB 2420</u>, pertaining to establishing tax withholding requirements when certain employees work in multiple states, will have a hearing on Wednesday in the <u>House Tax Committee</u>.

The bill would exempt certain employees who perform employment duties in more than one state from income tax withholding and reporting requirements unless the earnings occurred in the state of the employee's residence, or in a state that the employee performed employment duties for more than 30 days during the calendar year.

The bill is being advocated for by the Kansas Chamber of Commerce, among others.

FOREIGN OWNERSHIP BILLS HOT TOPIC IN TOPEKA

The debate on foreign ownership of land took center stage this week.

Republican Attorney General Kris Kobach testified in support of <u>SB 446</u>, which would prohibit a person owned by, controlled by, or subject to the jurisdiction or direction of a foreign government from acquiring any interest in any parcel of real property located in Kansas that is three acres or more. The provisions of the bill would not apply to any interest that was acquired prior to July 1, 2024.

Kobach noted that while Canadian citizens and businesses own the largest share of US land, China's share is significant and growing. According to the USDA, Chinese landowners control approximately 383,000 acres of U.S. farmland. From 2010 to 2021, the dollar value of known Chinese-owned farmland increased from \$81 million to \$1.9 billion.

Kobach also noted that 24 states currently have some prohibition of foreign ownership of land on the books. The scope and breadth of these new laws varied from state to state.

<u>SB 446</u> was strongly opposed by groups representing agricultural interests, including Kansas Farm Bureau and the Kansas Livestock Association.

Another bill related to the subject was introduced by the House Majority Leader Chris Croft (R-Overland Park) on Thursday.

Unlike Kobach's bill, <u>HB 2766</u> would only apply to property owned by "countries of concern" which are defined in the bill as China, Cuba, Iran, North Korea, Russia, and Venezuela. Further, the bill would apply to land located within 150 miles of the boundary of any military installation located in this state or an adjacent state.

No hearing has yet been set for HB 2766. It also has not been announced whether the Senate bill will be worked.

BILL TO LIMIT HEALTH OFFICIALS TO BE HEARD

<u>SB 391</u>, which will be heard in the <u>Senate Public Health & Welfare Committee</u>, would amend current statute to change the authority of the Secretary of Health and Environment to a supervisory role whereas recommendations rather than action may be made to prevent the introduction and spread of infectious diseases within the state.

The secretary may adopt policies, rather than rules and regulations, but will not be allowed to expand their authority over state of disaster declarations, violate any provisions related to infectious diseases, or exert orders for quarantine or isolation. The authority of local health officers would be limited in a similar manner.

Similar bills have been advanced in Kansas since the advent of the COVID-19 pandemic but have not become law.

The bill will be heard on Thursday.

DIGITAL DRIVERS' LICENSES TO COME TO KANSAS?

Mobile phones may soon contain your drivers' license in the state of Kansas.

<u>SB 477</u> would provide for the issuance and use of digital drivers' licenses and digital identification cards through a secure and uniform issuing system administered and authorized by the division of vehicles. The bill provides clarification on the limits to use of such digital proof for the purposes of collecting personal information for sharing or selling.

The bill was introduced in the <u>Senate Transportation Committee</u> on behalf of the Department of Revenue. It will have a hearing on Thursday.
